- ❖ All Course Coordinators are required to submit a proposal well in advance in the prescribed format (as per TMC guidelines) along with the course schedule for obtaining financial approval of Director, CWPRS for conducting the course efficiently and timely. All correspondence in this regard should be routed through the concerned controlling Laboratory Head, Chairman TMC and then Finance Officer.



- ❖ The expenditure for conducting training Course could be charged to Training Expenses and shall be kept as minimum as possible. For any query in this regard, Finance Officer, CWPRS may be consulted.
- ❖ TMC guidelines should be followed by the course coordinator. Feedback form, certificate, banner etc should be as per Annexure attached to TMC guidelines.
- ❖ The Training Courses will be organized OFFLINE/ ONLINE as mentioned.
- ❖ Course fee will be NIL for ONLINE course and the participants are required to get registered before one week of the scheduled day of start of the course by contacting the course Coordinator.
- ❖ The link for the ONLINE Course shall be generated before 2-3 Days of start of the course and shall be sent to the registered participants.
- ❖ The OFFLINE courses will be organized at CWPRS, PUNE for 25 participants, which comprises classroom lectures, visit to models and laboratories, demonstrations of equipment and software as applicable.
- ❖ Course fee (Rate per day per participant for OFFLINE course): Rs.2000/- per day for Central Govt. /State Govt. /PSU / Faculties of colleges; Rs.2500/- per day for Private Institutions /Companies; Rs.1000/- per day for Indian students; \$100 per day for foreign nationals; NIL for implementing agencies (IAs) under NHP.
- ❖ The course fee includes only course material and working lunch. Limited accommodation at nominal cost is available at CWPRS guest house for the participants of the training programme on a first come first serve basis.
- ❖ Interested participants may register themselves before due date by writing to the course coordinator along with the registration fee for the course paid through demand draft drawn in favour of PAO, CWPRS, Khadakwasla, Pune – 411024 or by registering through “Bharat Kosh” at <https://bharatkosh.gov.in/userregistration.aspx> and following necessary steps thereon as one time process for all future payments. E-payments by any other means shall not be entertained. The remitter must read the guidelines and follow the same while making the payments. (<https://bharatkosh.gov.in/userGuide.aspx>). The details of e-payment must be informed to the office by email.
