Have your Ministry, the record of how many Govt. employees who have disabled dependent children under all categories mentioned in this act? If not, upto when your Ministry will do so? If available provide the following information:

1. How many Govt. employees in all Ministries/Departments have "Divyang"/disabled dependent children under all categories mentioned in this act in the year 2016?
2. How many Govt. employees were exempted from transfers through this act in the year 2016 (01.01.2016 to 31.12.2016) (Ministries/Department wise)?
3. How many Govt. employees in these mentioned disabled dependents categories were allowed to opt for their choice of transfer/postings in the year 2016 (Ministry/Department wise)?
4. How many such requests for transfers are still pending for consideration from 01.01.2016 to 31.12.2016 (Ministries/Department wise)?
5. How much average time period (shortest and longest) was taken to finalize these requests in the year 2016 by the Ministries?
6. What type of allowance an employee can avail, who have disabled child?

With reference to your application, the requisite replies/information received from the concerned division of CWPRS under relevant provisions of the act is furnished below.

Point No.1 – 5 : Central Water and Power Research Station is a subordinate office of the Ministry of Water Resources, RD&GR situated at Khadakwasla, Pune – 24 and there are no branches/ office outside Pune. Hence question of transfer does not arise.
