- The Scientist C, Construction, Procurement and Planning Division (CPPD), CWPRS, Pune invites bids electronically for construction of works detailed in the Table above. The Bidders may submit Bids for any or all of the packages listed in the Table.
- The intending bidder must read the terms and conditions of CPWD-6 carefully. He should only submit his bid if he considers himself eligible and is in possession of all the documents required.
- 3. Eligibility of bid submission is C.P.W.D. as well as non C.P.W.D. bidders provided they produce definite proof from the appropriate authority, which shall be to the satisfaction of the competent authority, of having satisfactorily completed similar works/civil works of magnitude specified below in the last 7 years ending last day of the bid submission:
  - a) Three similar nature of works / civil works of each of value 40% of estimated cost or
  - b) Two works of each of value 60% of estimated cost or
  - c) One work of value 80% estimated cost.
- 4. Information and instructions for bidders posted on website shall form part of bid document.
- 5. The bid document consisting of specification, the schedule of quantities of various types of items to be executed and the set of terms and conditions of the contract to be complied with and other necessary documents can be seen and downloaded from website: www.cwprs.gov.in or www.eprocure.gov.in /eprocure/app free of cost.
- 6. The Bidding Document is available online and can be downloaded free of cost by logging on to the website <a href="http://eprocure.gov.in/eprocure/app">http://eprocure.gov.in/eprocure/app</a> or <a href="http://eprocure.gov.in/eprocure/app">http://eprocure.gov.in/eprocure/app</a>. The bids are to be submitted online through the e-procurement portal only i.e. <a href="http://eprocure.gov.in/eprocure/app">http://eprocure.gov.in/eprocure/app</a>. Bids submitted manually will not be accepted. The bidders would be required to register in the website which is free of cost.
- 7. For submission of the Bid, the Bidder is required to have Digital Signature Certificate (DSC) from one of the Certifying Authorities authorized by Government of India for issuing DSC. Aspiring bidders who have not obtained the user ID and password for participating in e-procurement in this Project, may obtain the same from the website: <a href="http://eprocure.gov.in/eprocure/app">http://eprocure.gov.in/eprocure/app</a>
- 8. The EMD should be submitted in the form of DD/FDR in favour of "Pay and Accounts Officer", CWPRS, Pune payable at Pune with a validity period of 75 days from the date of opening of Technical Bids. If validity is less than the required period, the bid will be rejected.
- Exemption of Bid security /EMD is allowed by producing NSIC certificate (physically) only under PP policy exempted for activities mentioned in the store details section of the said NSIC certificate. Other certificates are not allowed for seeking Bid Security/ EMD Exemption
- 10. In place of EMD amount submission and uploading the submitted information, bidders may upload a "Bid Security Declaration" duly signed in specified proforma in the bid document and the original copy of the same should be deposited to the Office of The Scientist C, Construction, Procurement and Planning Division (CPPD), CWPRS, Pune –24 before bid opening date and time as specified in the bid document, failing which the Bids will be declared non-responsive and liable to be rejected
- 11. Bids must be submitted on <a href="http://eprocure.gov.in/eprocure/app">http://eprocure.gov.in/eprocure/app</a> on or before 15:00 hours on 07/10/2025 and will be opened online on 08/10/2025 at 15:00 hours.

If the office happens to be closed on the date of opening of the Bids as specified, the Bids will be opened on the next working day at the same time and venue. Any bid or modifications to bid received outside e-procurement system will not be considered. The electronic bidding system would not allow late submission of bids.

12. The bidders are required to submit specified **original documents** including original EMD/Bid Security in approved form (including EMD exemption certificate, if any) with **The Scientist** – **C, Construction, Procurement and Planning Division (CPPD), CWPRS, Pune** at the address given below before **08/10/2025** at **15:00 hours**, by registered post/speed post/courier or by hand, failing which the Bids will be declared non-responsive and **liable to be rejected**.

13. On opening date, the bidder can login and see the bid opening process. After opening the bids, he will receive the competitor bid sheets.

14. The bidder can upload documents in the form of PDF format only.

15. The contractor whose bid is accepted will also be required to furnish performance guarantee (PG) along with copy of applicable licenses/registrations or proof of applying for obtaining labour licenses, registration with EPFO, ESIC and BOCW Welfare Board (if applicable) and Programme Chart (Time and Progress) within the period specified in Schedule F i.e. 15 days from the date of issue of letter of acceptance

16. The lowest bidder (L1) shall physically submit the certified copy of all scanned and uploaded documents as below within <u>five working days</u> after uploading of financial approval of the bid in the office of The Scientist – C, Construction, Procurement and Planning Division (CPPD), CWPRS, Pune. If the successive bidder fails to submit the certified copy of all uploaded documents at CWPRS within the specified period, his bid is liable to be rejected and he will be blacklisted for 3 years or more and his registration may also liable to be cancelled by approving authority

The following documents shall be scanned and uploaded mandatorily on or before the last date for online submission of bids failing which the bid will be treated as non-responsive and shall be rejected.

COVER - I (Technical Bid)

- Demand Draft or FDR of any Schedule Bank against EMD, which is valid for a period of 75 days from the date of opening of Technical Bids.
- ii. Enlistment of the Bidder
- iii. Certificate of Registration for GST.
- iv. Latest GST return of the state in which the work is to be taken up, if already obtained by the bidder OR If the bidder has not obtained GST registration in the state in which the work is to be taken up, or as required by the GST authorities, then in such a case the bidder shall only scan and upload following undertaking with other bid documents.

"If work is awarded to me, I/We shall obtain GST registration certificate of the state, in which work is to be taken up, within one month from the date of receipt of award letter or before release of any payment by CWPRS, whichever is earlier, failing which I/We shall be responsible for any delay in payments which will be due towards me/us on account of the work executed and /or for any action taken by CWPRS or GST department in this regard"

v. Work Experience Certificate of similar nature is to be considered only.
